## Typical Insertion Loss Characteristics:

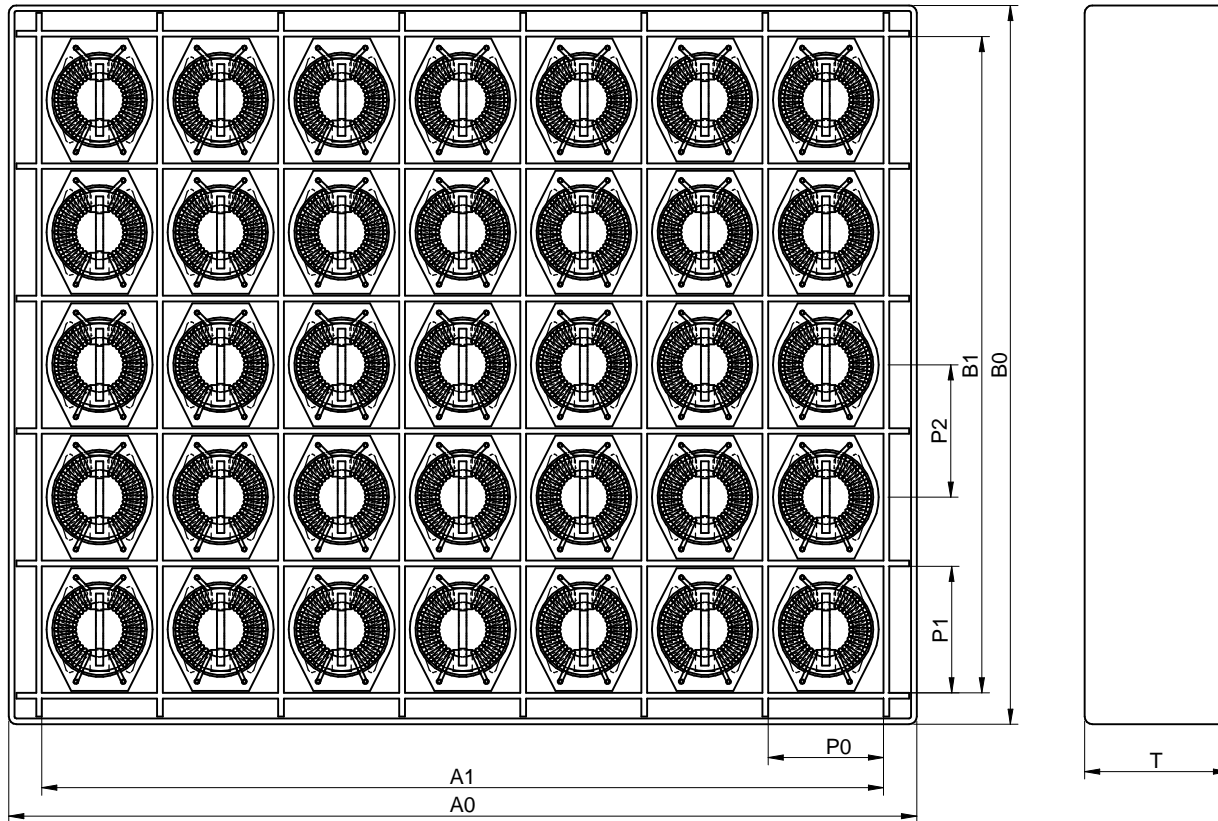
